## Office Order

**Subject:- Regarding inspection/visit reports/surprise checks.**

Govt. of India, Department of Industrial Policy and Promotion, Ministry of Commerce and Industry has formulated Business Reform Action Plan, 2016 for States /UTs for enabling Ease of Doing Business to the entrepreneurs.

For implementing the Action Plan, the State Govt. has decided certain reforms to be carried out by the concerned department including the Punjab Pollution Control Board. As one of such action points, inspection/visit reports are to be made available in a time bound manner.

In view of the above, following procedure is, hereby, laid down with regard to the submission of inspection reports of the industries:-

"The inspection/visit reports for processing the consent application of the industries shall be uploaded online through Online Consent Management & Monitory System (OCMMS) by the visiting officers within 48 hours of his/her visit".

These orders are issued with the approval of the Chairman of the Board and shall come into force with immediate effect.
